**Pension under CCS Pension Rules on combined service in the Civil Aviation Department  
and the National Airports Division of Airports Authority of India**

Respected Sir,

I joined the Civil Aviation Department under GPF cum Pension Scheme. Consequent upon formation of National Airports Authority, I was en-masse transferred to National Airports Authority from 1.June.1986 under section 13(3) of the National Airports Authority Act, 1985. Ministry of Civil Aviation fixed the date of absorption in National Airports Authority as 2.October.1989 in terms of para 3 of Department of Pension & Pensioners Welfare O.M. 4/18/87/P&PW-(D) dated 5.July.1989. But, National Airports Authority failed to formulate its own service conditions as obligated under para 4 of said O.M dated 5.July.1989. In the absence of service conditions of National Airports Authority, para 1(c) & 1(d) of O.M. 5.July.1989 became infructuous and I retained Government Pension scheme on absorption in National Airports Authority from 2.October.89 under Public interest.

Ministry of Civil Aviation finalized modalities for disbursement of Pension to absorbees under CCS Pension Rules and issued order on 26.June.2001. Benefit of this order was not extended to nearly 2400 absorbees who had less than 10 years of service in the Government on the date of absorption.

Right of pension on combined service is available to each absorbee irrespective of length of service in Government, as clarified by Department of Pension & PW vide O.M. No.4/2/2010-P&PW-(D) dated 30.August.2010 and acting upon this O.M., Ministry of Civil Aviation issued orders in this regard on 07.October.2010.

Airports Authority of India is yet to implement the said order issued by Ministry of Civil Aviation on 07.October.2010. Under this condition I am compelled to approach you for seeking implementation of the order.

I may also be intimated, if I am required to take any further action in this regard.
