



MINUTES OF CEC MEETING HELD ON 01/08/2016

A Central Executive Council Meeting was held on 1st August 2016 at ATC Guild (I) office and the following members attended the meeting.

At the outset President welcome all members and apprised about the agenda. The following issues were deliberated at length and the decisions taken were as under:

- 1. ADJUSTMENT OF INCREMENTS:** It is evident from the documents and circulars available with ATC Guild (I) that when AAI was formed after the merger of NAA and IAAI the management took a decision to grant additional increments of one or two to Executives in NAA and upgraded the pay scales of Executives of IAAI. Now, after 20 years the decision of the management to adjust the increments from erstwhile NAD officials, where sizable percentage of affected executives are from ATM disciplines, is unjustified and demoralizing. Hence, after discussing the various aspect of this decision of the management, it is decided to seek the help of Judiciary. It is also resolved that at least 2 – 3 RS / BS will be advised to explore the options. The RS / BS of Chennai, Cochin and Kolkata have been requested to do the necessary ground work. The RS /BS would be doing the follow-up work on behalf of CEC and the total cost / expenditure will be borne by CEC, ATC Guild (I). CEC will also take a decision whether the case will be filed at one or more places.
- 2. ORGANIZING OF SEMINAR ON WORLD ATC DAY:** After due deliberations it is decided and resolved that the ATC Day (20th October 2016) will be celebrated at Delhi. It is also resolved that due to various reasons the Seminar and other facilitations will be done only on 20th October, 2016. A detailed circular will be issued by the General Secretary to all Branches for support and participation.

3. **Central Council Meeting:** It is decided to conduct Central Council meeting on 21st October 2016, i.e. the day following Seminar. All Central Council members are requested to plan their travel to Delhi accordingly. The provisional agenda for the meeting will be circulated by the CEC before 21st August, 2016.
4. **Status of PRP:** All CEC members were briefed about the developments taking place on this issue. A mail has already been issued to all Regional and Branch Secretaries regarding the same. In the meantime we have initiated discussions with other Associations and have drawn some action plan to meet Chairman, AAI and Secretary, MOCA on this issue. General Secretary will disseminate updates at regular intervals.
