**MINUTES OF CENTRAL EXECUTIVE COUNCIL MEETING HELD ON  
04.03.2017**

A Central Executive Council meeting was held on 04.03.2017 at New Delhi and the following attended the Meeting:

At the outset, President welcomed all members and apprised about the Agenda. The following issues were discussed and the decisions made were as under:

**1. Election to the Central Executive Council:**

At present CEC is in receipt of the list of members of various regions. However, there are some disputes and discrepancies. A week time (i.e. by 15<sup>th</sup> March, 2017) is given to all Regional Secretaries to clear and resolve the disputes. The list corrected so far will be published by 8<sup>th</sup> March, 2017. **In the absence of any additional feedback, this list will be treated as final.**

CEC also decides that the members, who are paying at different Regions/Branches i.e. other than the place of posting due to some unavoidable reasons shall be considered as valid members, if there are no dues.

***Treasurer briefed the house that the Membership status of the following stations and/or individuals may be checked by the respective Regional Secretaries/Branch Secretaries:***

*1. Northern Region : CEC has not received Membership list as well as CEC share of following stations :*

- a. Dehradun*
- b. Pantnagar*
- c. Khajuraho*
- d. Udaipur*
- e. Gaggal*
- f. Shimla*
- g. Gorakhpur*
- h. Kanpur*

2. *Regarding the status of Lucknow Branch, it has been resolved that the final decision related to Lucknow membership would be taken after seven days by ascertaining the current status of the branch from Regional Secretary, NR and Branch Secretary Lucknow.*

*In addition, the CEC share of members who have paid their dues later (at IGI Airport and Amritsar) has not been remitted.*

3. *Southern Region :*

- a. *Calicut : CEC has received only list of members without CEC share.*
- b. *Tirupati : CEC has received amount of Rs. 7300/- up to March, 2012.*
- c. *Belgaum : CEC has no details about members of Belgaum branch.*
- d. *Pondicherry : CEC does not have the details of members at Pondicherry.*
- e. *Mangalore : CEC has not received the CEC share for period of June, 2014 to June, 2015.*

4. *Western Region: CEC has not received clarification from RS, WR which was sent to RS, WR. So the names of members regarding whom clarification was sought has not been included in the list.*

5. *Eastern Region: CEC has not received clarification from RS, ER about few members. So their names have not been included in the list. In addition, CEC has not received the balance amount of Rs. 68933/-.*

6. *North Eastern Region: CEC has not received the dues collected from some members. So their names have not been included in the list. Some members have stated that they are paying at their previous stations but same could not be confirmed.*

The final membership list would be submitted to Bangalore Branch on 15<sup>th</sup> March, 2017. In the meantime Bengaluru Branch may initiate the election process to complete it on or before 31<sup>st</sup> May, 2017.

Some regions have not mentioned about few stations where ATCOs are posted Even though implicit, the Regional Secretaries are advised to mention “no members” for these stations. It is also advised to all RS/BS to give details of the non-members i.e. the ATCOs who are not members of ATC Guild at the earliest for record.

**Contact details of various Branch Secretaries** which are available with CEC would be circulated to all the Regional Secretaries along with the Membership list. All Secretaries are advised to make correction to the correct contact details, if any and submit to CEC by 10<sup>th</sup> March, 2017 for onward transmission to Election Commission.

The CEC authorizes GS and Treasurer for any addition and deletion to the membership which will be intimated to the Election Commission and the same shall be displayed in the ATC Guild Web site.

Recognition of the associations by AAI Management: AAI Management has issued guidelines for recognition of executive Associations on 03<sup>rd</sup> March, 2017. Earlier all the Associations had jointly rejected the proposal of AAI Management. CEC decides to protest the arbitrary and authoritarian activity of AAI Management in co-ordination with other Associations.
