4. They will be on probation for a period of one year from the date of joining.
5. These promotions shall be subject to the final outcomes of the Writ Petition No. 1662/2008 in terms of the order dated 11.08.2008 at Hon'ble High Court of Delhi and OA No. 050/00455/2017 dated 11.01.2018 at Central Administrative Tribunal, Patna Bench, Patna.
